Include the following with your entry:

- Six (6) original copies including artwork and liner notes. Music must be submitted on CD.
- *One (1) brief bio (no more than 50 words). To be used for promotional purposes.
- *One (1) photo of entrant(s). To be used for promotional purposes. JPEG or TIF files are preferred. Hard copy photos must be 5x7 in black and white - no photocopies or laser prints.
- *One (1) press kit (including full bio, press clippings, any additional promotional materials, photos, etc.).
- *Proof of product release date (This can include a letter from a record company or distributor, press releases, reviews, proof of delivery to radio or retail, etc.).
- Entry fee (\$10 for members and \$29 for non-members, per submission, per category). All fees are non-refundable, even if the entrant is disqualified or not chosen as a nominee.
- A completed entry form and signed authorization provided by MFM. Reformatted forms will not be accepted.
